SECTION V - REACTIVITY DATA -

STABILITY: STABLE UNDER NORMAL CONDITIONS OF HANDLING

CONDITIONS TO AVOID: DO NOT SPRAY NEAR FIRE OR OPEN FLAME. DO NOT STORE ABOVE 120°F. ESPOSURE TO SUNLIGHT OR OTHER HEAT MAY CAUSE BURSTING.

SECTION VI - SPILL OR LEAK PROCEDURES -

CLEAN UP: REMOVE ALL IGNITION SOURCES. VENTILATE. AVOID BREATHING VAPORS AND REMOVE WITH INERT ABSORBENT.
